From Morris County

Take Route 287 north to Rout 80 East. Follow signs to 280 East. Use exit 4A-Eisenhower Pkwy. At first light turn left onto Eagle Rock Ave. Turn left on to Passaic Ave. at 1st traffic light. At 4th traffic light turn left into Crane's Mill.

From Short Hills, Summit or Chatham Areas

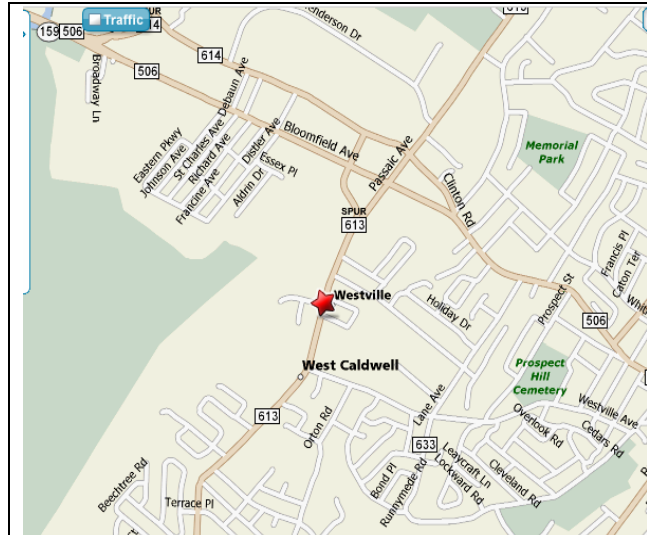
Take JFK Pkwy. Turn left on South Orange Ave. Turn right on Eisenhower Pkwy. At 3rd light after route 10, turn right onto Eagle Rock Ave. At 1st light turn left (Passaic Ave.) At 4th traffic light turn left into Crane's Mill.

From North NJ and NJ Turnpike

Take Rout 80 West to exit 52 (Lincoln Park, Fairfield, The Caldwells) Bear right at end of ramp to Caldwells on to Two Bridges Rd. which becomes Passaic Ave. Pass Rt. 46. Go 13 traffic lights.

From Central & Southern NJ

Take Garden State Pkwy. North to exit 145. Follow signs to 280 W. Continue to exit 4A. Turn left at 1st traffic light (Eagle Rock Ave.) At 1st light turn left on Passaic Ave. At 4th traffic light turn left into Crane's Mill.

Exhibiting members with paid up dues may submit **one (1) painting that has not been previously exhibited with the EWCC.** All entries must be **water media**, properly framed, with **white or neutral mats**, and ready for hanging. Framed work cannot be smaller than 16” or exceed 40” in any direction. **Metal frames and full sheet paintings must be under Plexiglas.** Class work, collage, computer generated art, or prints, will not be accepted. EWCC reserves the right to decline any painting deemed inappropriate. All subject matter must be suitable for family viewing.

Receiving: Saturday Nov. 1st

Please deliver your painting to the Crane’s Mill Town Square Gallery between 10 am -12 noon. There is a parking lot near the entrance area. If you need it, ask the receptionist for a cart to carry artwork from the canopy at the front door to the gallery.

Reception: Saturday Nov. 8th

Opening Reception 2 pm - 4 pm in the Town Square Gallery, through the main lobby to the left. Awards ceremony at 3 pm. Please plan to attend and bring your friends. Refreshments will be served.

Closing: Sunday Nov. 30th
